7. Per)fluorinated organic surfactants, which include perfluorooctane sulfonate (PFOS) and perfluorooctanoic acid (PFOA) and substances dual use.

Products belonging to the POKEPACK CARTON family do not contain PFOS and PFOA compounds.

The substances used in the plastic coating do not contain any dual use additives.

8. Requirements to use of material or product:

(i) The paper articles are intended to come into contact with all types of food

(ii) The service temperature range for the paper articles is 5°C to + 90°C. Can be used as packaging for food storage at room temperature or below including contact with food up to 100°C for no more than 2 hours. The bowls can be used as packaging for storing food at room temperature and higher or lower according to individually verified refrigeration conditions, excluding freezing.

(iii) Contact area/volume of simulant: 6 dm² : 1 kg food

(iv) Storage conditions: the warehouse should be kept clean, ventilated with relative humidity between 50% and 80% to prevent damage to the finished product.

The finished product must be stored 15 cm from the floor, 15 cm from the wall and 50 cm from the top (roof).

(v) Recommended storage temperature - 10°C to + 50°C

(vi) Recommended maximum heating time of 8 minutes with a microwave of 850 watt maximum.
